1. Presentation of the Fiscal Year 2022 Budget

Mr. Troyer stated that since the Committee reviewed the budget proposal at the September meeting, there have not been any major changes. The 911 millage revenue was updated to reflect the projections the Authority received from the county. He noted the largest change since the September Committee meeting was in health benefits. He explained that he used a universal 5% increase for health benefits because we did not have the renewal rates, but the actual came in quite a bit higher -8.75% increase for the HSA plan and 10.5% for the HMO plan. The Notice of Public Hearing will be posted in the newspaper and in electronic form if this committee approves.

Mr. Martin thanked Mr. Troyer for putting the budget together and said it looks good. He thought it should be passed on to the Executive Committee.

"Motion by Mr. Ritsema, second by Mr. Thompson to accept and recommend Board approval for the Fiscal Year 2022 Budget as presented."
