July 14, 2022

ITEM 1 – CALL TO ORDER

The Regular Meeting of the Kalamazoo County Consolidated Dispatch Authority Board was called to order by Vice Chairperson Jim Ritsema at 3:30 p.m. in the Chief Switalski Meeting Room, Kalamazoo County Consolidated Dispatch Authority, 7040 Stadium Drive, Kalamazoo, Michigan on Thursday, July 14, 2022.

- A. Executive Director Report
 - 1. Administration's Monthly Report

Mr. Troyer stated the report was included in packet. He noted that there was now power at two tower sites, but we are still waiting on power at Portage & Oshtemo. The transformer is on backorder and if it takes much longer, we will not make our deadline.

Mr. Troyer stated the FEMA grants for the RAVE Alert and the cleaning of the center were received June 30.

Mr. Ritsema welcomed new Portage City Manager Pat McGinnis to the Board. He appointed him as Chair of the Personnel Committee, a position previously held by Adam Herringa.

Mr. Troyer stated the Personnel Committee had a special meeting and provided an update on negotiations. There was no action needed.

 - b. MPSCS Integration Agreements (three separate Agreements)

Mr. Troyer the minutes were informational only. There were three MPSCS Integration Agreements. Mr. Troyer indicated that any time a new entity joins that is not a public safety entity or additional infrastructure is necessary, the MPSCS must get permission to allow the user to join from KCCDA. The documents were reviewed by legal and unanimously supported by TAC.

Mr. Gisler stated the new Justice Center is on schedule and on budget. The State Court Advisory Board determined that Kalamazoo needs an extra judge, so they need to try to find space for them. The courts will either keep one judge at Gull Road or refuse the judge.

Mr. Gisler stated Axon, the maker of their body cams, road tour came through and they had a drone that could go up nearly 400 feet. That's impressive technology.
